INVITATION TO BID FOR Supply & Delivery of Solid Waste Machinery For the use of the Municipality of Taal

- The Municipal Government of Taul, through the General Fund of 2014 intends to apply the sum of Twelve Million Pesos (P12,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply & Delivery of Solid waste Machinery for the use of the Municipality. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Municipal Government of Taal now invites bids for Supply & Delivery of Solid waste Machinery for the use of the Municipality. Delivery of goods is required on January 17, 2015. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidder.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from Municipal Government of Taul and inspect the Bidding Documents at the address given below from 8:00 to 5:00pm.
- A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of twenty five thousand pesos (Php25, 000.00).
- 6. Bids must be delivered to the address below on or before December 2, 2014 10:00 am at BAC Office, Ground Floor, Municipal Bidg, Taal, and Batangas. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 7. The Municipal Government of Taal reserves the right to accept or reject any bid, to annual the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
