## INVITATION TO BID FOR Supply of Labor & Materials for the Concreting of Iba-Ipil Road At Brgy. Iba Kanluran, Taal, Batangas

- 1. The Municipal Government of Taal, through the SARO-BMB-D-16-0000031 dated January 8, 2016 intends to apply the sum of Eight Hundred Fifteen Thousand Pesos (P815,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Labor & Materials for the Concreting of Iba Ipil Road at Brgy. Iba Kanluran, Taal, Batangas. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Municipal Government of Taal now invites bids for Supply of Labor & Materials for the Concreting of Iba Ipil Road at Brgy. Iba Kanluran, Taal, Batangas. Completion of the Works is required on May 28, 2016. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail
  criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184),
  otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from *Municipal Government of Taal* and inspect the Bidding Documents at the address given below from 8:00 to 5:00pm.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *One Thousand Pesos* (*Php* 1,000.00).
- 6. Bids must be delivered to the address below on or before March 15, 2016 10:00 am at BAC Office, Ground Floor, Municipal Bldg, Taal, Batangas. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.
- The Municipal Government of Taal reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
